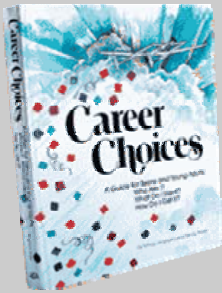

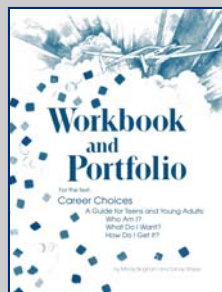

Why it Works

Suppose Kyle is failing algebra. His teacher, Mr. Fernandez, reviews his 10-year plan online and discovers Kyle wants to be a high school history teacher and coach. Mr. Fernandez then has the opportunity to point out to Kyle that, upon review of his goals and dreams, there is a problem if he doesn't pass biology, as it is required to get into college. Pointing out the deficit, Mr. Fernandez can suggest strategies for getting Kyle back on track with his biology. If Kyle resists, Mr. Fernandez can suggest he rewrite his 10-year plan to redirect his aspirations to match his effort.

Because Kyle has completed a *Career Choices* course, he will fully understand the consequences of that action and will be far more likely to buckle down and make the effort required to complete his academic coursework.
